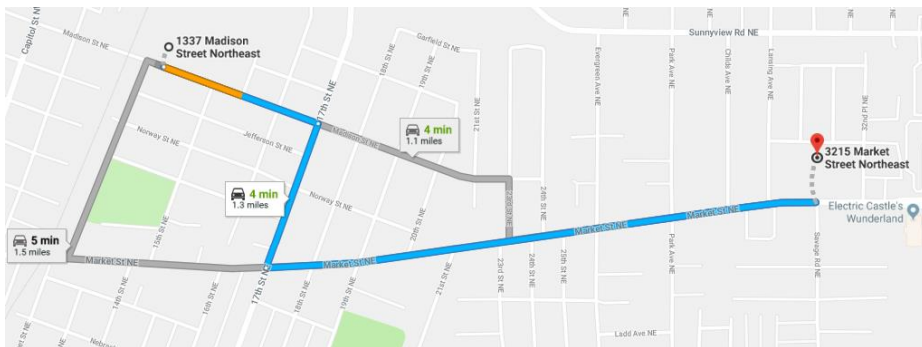

THERE SHALL BE NO DRILLING NOR INTENSIVE OR CORRECTIVE TRAINING OF DOGS ON THE MATCH GROUNDS OR PREMISES.

ALL DOGS shall be kept on leash except when in the Obedience, Rally, or warm-up rings.

NO DOG WILL BE ALLOWED IN THE MATCH AREA EXCEPT THOSE REGULARLY ENTERED IN THIS MATCH.

DOGS MUST BE READY FOR JUDGING. The club and its Match Secretary will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Owners or agents alone are responsible for the presence of their dogs in the judging ring.

DOGS NEED TO BE AT THE MATCH only at scheduled time of judging and may leave immediately thereafter, unless required for further judging.

THE MATCH-GIVING CLUB, MATCH SECRETARY, THEIR AGENTS, EMPLOYEES, ETC., assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

TRANSFERS of dogs to another conformation class MUST be made to the Match Secretary at least one half hour prior to the scheduled start of judging. Transfers by Junior Handlers from Novice to Open Class or from Open to Master Class MUST be made to the Match Secretary at least one half hour prior to the scheduled start of Junior Showmanship judging. SUBSTITUTIONS of Junior Showmanship dogs must be made at least one half hour prior to the scheduled start of Junior Showmanship judging.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by the judge, or barred from competition by action of the event's Match Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to compete at the match, no refund of entry fees will be made. The well-being of dogs, exhibitors, and spectators is of paramount importance and, in the event it is necessary to cancel or stop the match before completion, no refund of entry fee will be made.

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
